About The Welcome Directory

The Welcome Directory has a simple yet powerful vision:

To help faith communities become places where people who leave prison find **acceptance**. A place to **belong** that not only **nurtures faith** but also offers appropriate practical support.

People are at the very heart of this work; people who have found the benefits of being part of a faith community whether inside or outside the prison gates. Those leaving prison have a **name**, a **story** as well as **hopes and dreams** for their lives beyond the prison gate.

Aims & Objectives

For faith communities to explore the themes, ideas and information surrounding prison, imprisonment and release, leading to a greater understanding of the issues, such as the consequences of a prison sentence and the difference that support can make.

Beyond the Prison Gates

What do you think about people leaving prison?

Many prisons stand enclosed behind a **25ft fence** and unless it is an open prison, most prisoners are confined to often **cramped cells** for much of the time, **hidden away** from the general public; **forgotten**.

Unless we have experienced it for ourselves, it can be **hard to understand** the consequences of a prison sentence and what support can make a difference.





Starting Place Survey

Begin by becoming aware of where you are at. Allow your mind to bring some of your thoughts and feelings about prisons and prisoners to the surface, recognising that it can sometimes be **very hard to voice your honest thoughts**.

The Purpose of a Prison Sentence

The **Criminal Justice Act of 2003**, Section 142 makes the purposes of sentencing very clear. Any court dealing with an offender in respect of their offence must have regard to the following purposes of sentencing:

- (a) the punishment of offenders,
- (b) the reduction of crime (including its reduction by deterrence),
- (c) the reform and rehabilitation of offenders,
- (d) the protection of the public, and
- (e) the making of reparation by offenders to persons affected by their offences



Her Majesty's Prison Service website says that "it serves the public by keeping in custody those committed by the courts. Our duty is to look after them with humanity and help them lead law-abiding and useful lives in custody and after release."

A Snapshot of Prison

These statistics are collated by the Prison Reform Trust and are intended to give a snapshot of the reality of prison and the current conditions:

- **5,620 fewer staff** looking after more than **800 additional people**
- The prison population in England and Wales is approx. **85,500**
- The prison population has **risen by 82%** in the last 30 years
- The prison **daily food budget** is **£2.02 per person**
- **66%** of prisons in England and Wales were **overcrowded**, the majority doubling up in cells designed for one
- **49% of adults** are reconvicted within one year of being released. For those serving sentences of less than 12 months this increases to **58%**. For under 18-year-olds, **68%** are reconvicted within a year of release.

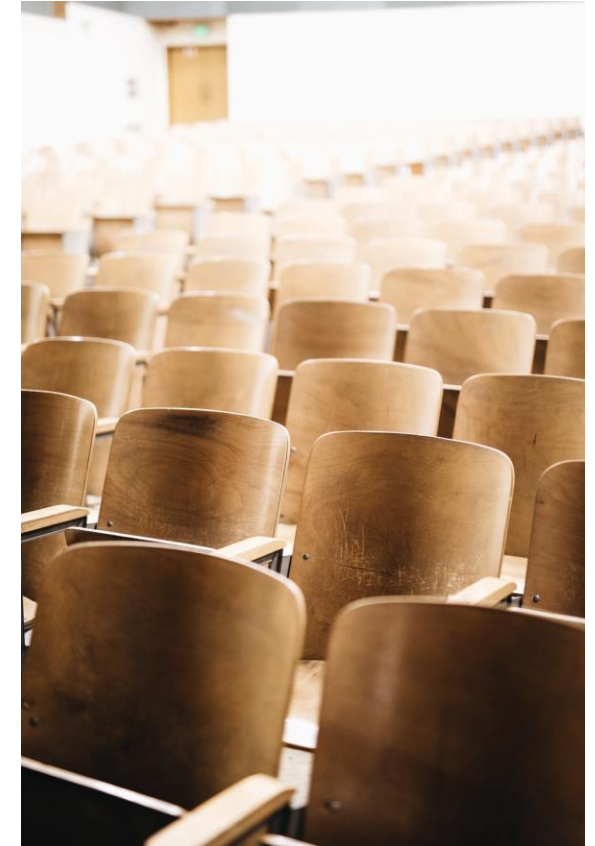

Everything Changes at the Prison Gates

- **Why does The Welcome Directory even exist?**
 - Approx. 80,000 men, women, and unfortunately children are released from prison every year
 - Approx. 15% of our prison population attends worship of some kind every week
 - Approx. 12,000 people with faith who worship in prison, leaves each month each year
 - Approx. 1,000 every month or 250 every week!
 - Yet only 20% join a faith community upon release
 - That's 200 people per week not connected with a welcoming and supportive faith community upon release every week

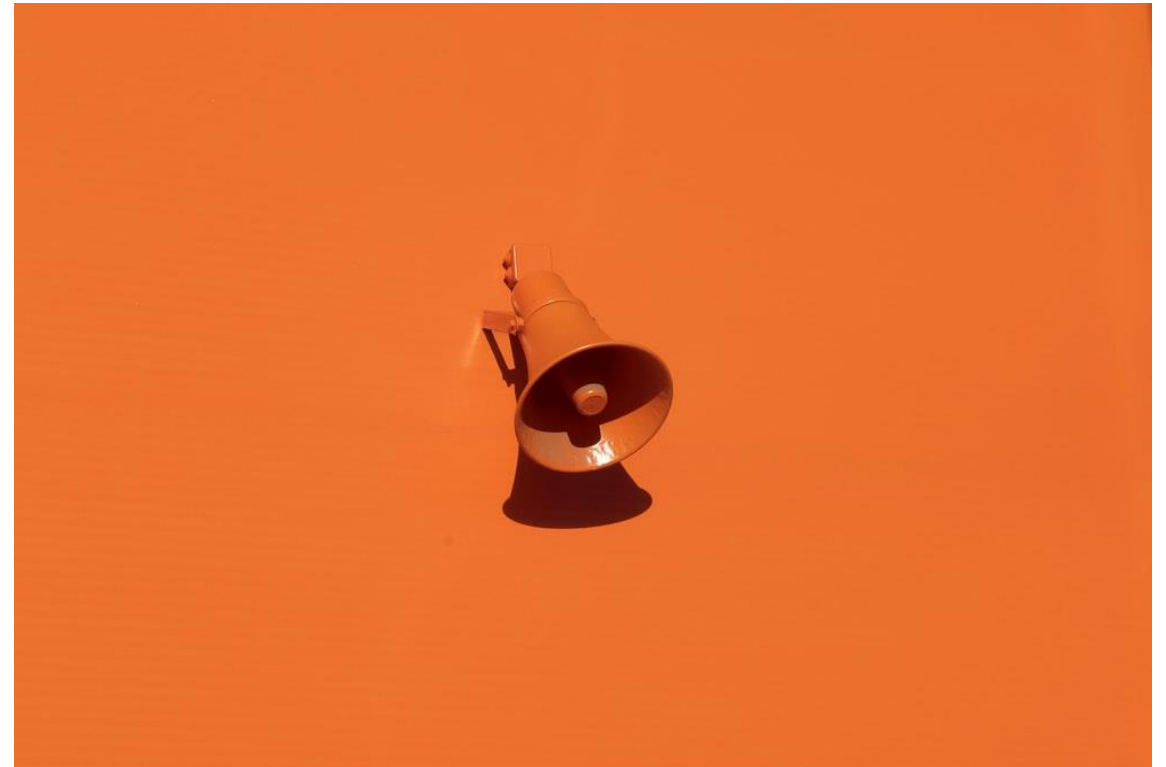

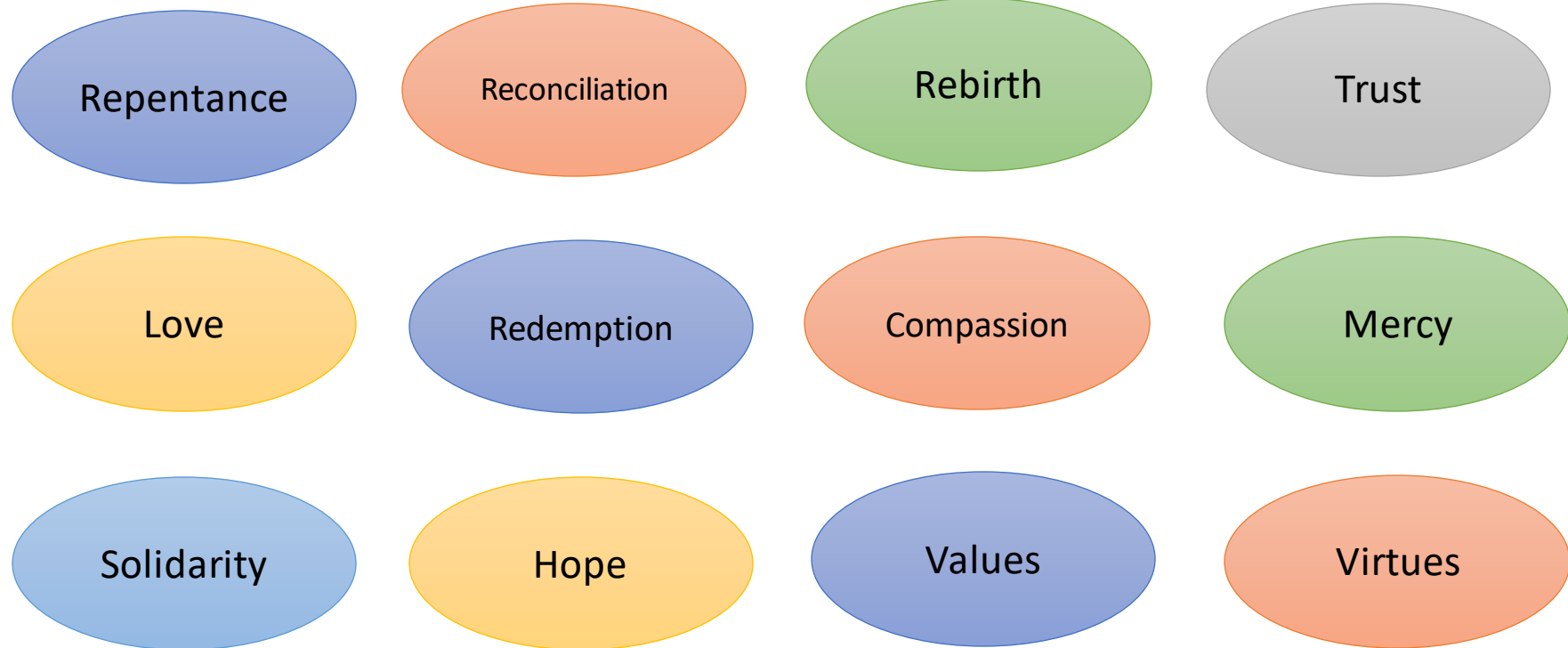
